10.15 Main lecture and discussion "Upheaval in the Arab World?"

The Turkish military offensive against the Kurds in Syria, the Kurdish referendum in Iraq, the continuing suppression of press freedom and freedom of speech in Turkey, Chaos in Libya, and various other countries pursuing their own geopolitical interests in these conflicts. These are only a few of the recent developments in the Middle East which seem to indicate that it is likely that people from this region will continue to seek protection elsewhere, for a variety of different reasons. Professor Dr. Mayer will speak about the main political, economic and social developments in the region, as well as their origins and will explain the global implications of the current conflicts.

11.15 Workshops

W 1 Family reunion – current developments

March 16th 2018: The date which countless refugees longed for – the date when the suspension of family reunions for people with subsidiary protection was supposed to end – *was supposed to ...* It has now emerged that the suspension has been extended and shall be followed by a quota system. In this workshop, the new laws in the area will be presented and some initial practical conclusions shall be drawn. In addition, some current information regarding "running issues" such as family reunion of siblings or the visa process of German embassies will be presented. The issue of family reunions via the Dublin III directive will also be touched upon. Speaker: **Ulrich Dewald** (Network Family reunion)

W 2 The political situation in Iran and consequences for refugees in the asylum process

Since December 2017, a strong movement of protest against the Iranian regime has been forming. This talk places the current events in their historic context and emphasises their special character. Subsequently, the speaker will present the relevant influential actors and their political aims and demands, as well as the role played by the German political and economic world and the possibilities for action by the German population in support of a movement striving towards emancipation. Against the backdrop of this, there will follow a critical look at the current decision practice of the BAMF and the courts.

W 3 Female refugees – their living situation and possibilities for support

Refugee women, particularly those travelling alone or who are single mothers, are particularly vulnerable. In many cases, they are in particular danger of becoming victims of violence due to non-gender-segregated accommodation. In addition, they face specific barriers which hinder their opportunities for participation, for example due to lack of childcare. What are the most common problems? How can support be provided? Which legal possibilities are there? What do professionals and volunteers have to bear in mind while dealing with this sensitive issue? These and other questions will be dealt with in this workshop.

W 4 The appeals process – How can volunteers be of assistance?

Many refugees appeal against the rejection of their asylum claims. Manfred Weidmann will explain, based on his experience as an asylum lawyer, how volunteers can be of assistance during the appeals process.

AG 5 Hostility towards refugees and supporters – what can I do?

People who work with refugees can come into contact with hostility on many different levels, for example if they themselves are attacked in connection with their work or if they witness hostility towards refugees. This workshop aims to create sensitivity amongst the participants and enable them to recognise right wing, racist and antisemitic violence, as well as looking at the specific characteristics and degrees of impact of right-wing violence. The speakers will also provide information about available support for those affected by right-wing violence and about possibilities for civil society support for such people. The aim is to enable participants to recognise the specific need for assistance in cases of right-wing violence and to assist those affected, according to their own resources.
